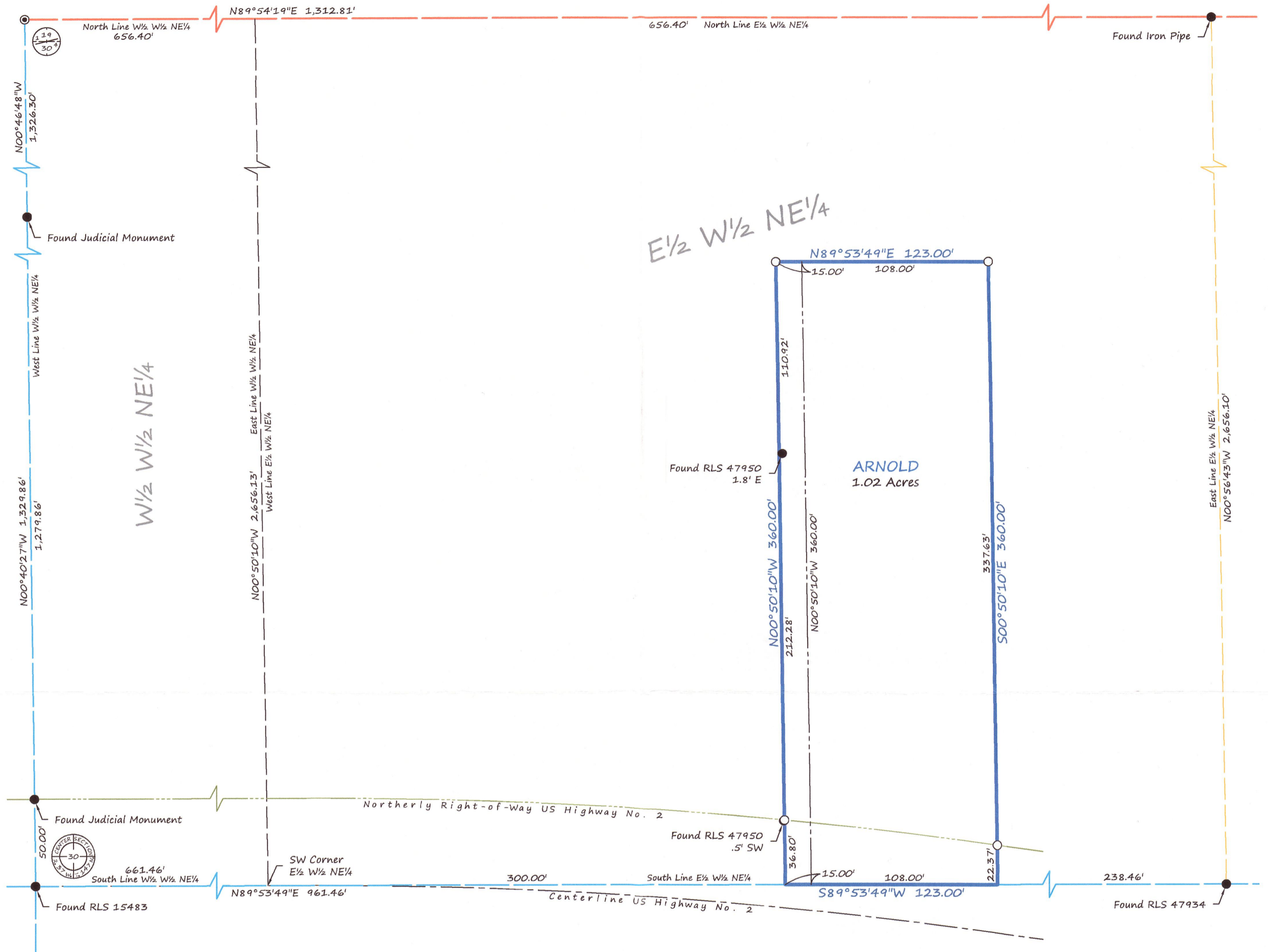

**DESCRIPTION PER RECORD DOCUMENT 155265:**

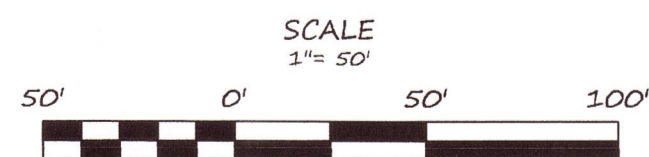
That part of the East Half of the West Half of the Northeast Quarter (E $\frac{1}{2}$ W $\frac{1}{2}$ NE $\frac{1}{4}$ ) of Section Thirty (30), Township One Hundred Forty-seven (147) North, Range Thirty-seven (37) West of the Fifth P.M. hereinafter referred to as "said tract"; described as follows, to-wit: Starting at a point 315 feet East of the Southwest corner of said tract; thence North and parallel to the West line of said tract, a distance of 360 feet; thence East and parallel with the South line of said tract, a distance of 108 feet; thence South and parallel with the West line of said tract, a distance of 360 feet, thence West along the South line of said tract, a distance of 108 feet, more or less, to the point of beginning.

**DESCRIPTION PER RECORD DOCUMENT 172115:**

That part of the East Half of the West Half of the Northeast Quarter (E $\frac{1}{2}$ W $\frac{1}{2}$ NE $\frac{1}{4}$ ) of Section Thirty (30), Township One Hundred Forty-seven (147) North, Range Thirty-seven (37) West of the Fifth P.M., hereinafter referred to as 'said tract', described as follows, to-wit:  
Starting at a point 300 feet East of the Southwest corner of said tract; thence North and parallel to the West line of said tract, a distance of 360 feet; thence East and parallel with the South line of said tract, a distance of 15 feet; thence South and parallel with the West line of said tract, a distance of 360 feet, thence West along the South line of said tract, a distance of 15 feet, more or less, to the point of beginning.
