

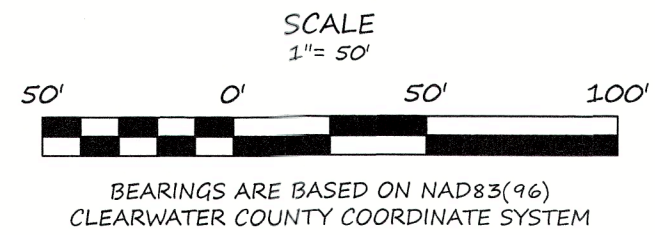
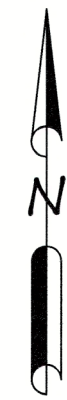
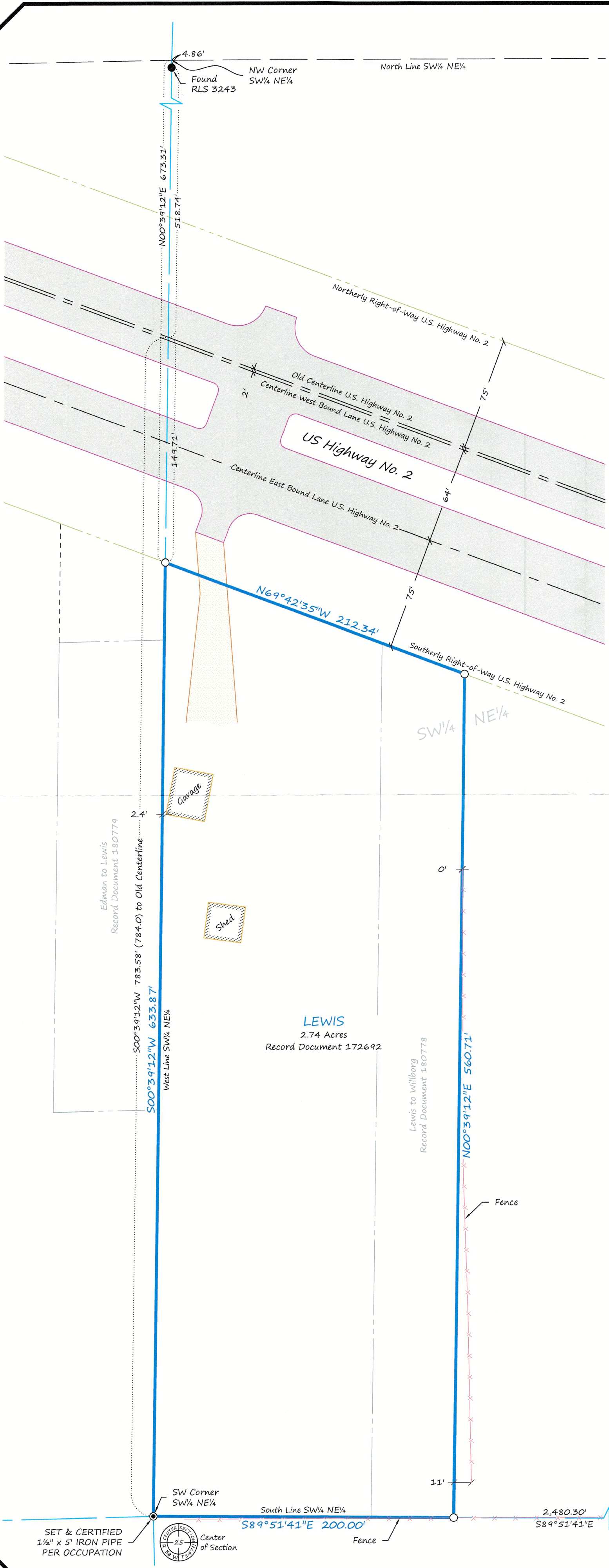
CERTIFICATE OF SURVEY

DESCRIPTION PER RECORD DOCUMENT 172692:

All that part of the Southwest Quarter of the Northeast Quarter (SW¼NE¼), Section Twenty-five (25), Township One Hundred Forty-seven (147) North, Range Thirty-eight (38) West of the Fifth Principal Meridian, more fully described as follows, to-wit: Commencing at the Southwest corner of the above-described forty, thence east on the South line thereof for a distance of 200 feet; thence at right angles and north parallel to the West line of said forty, to the Southern boundary line of U.S. Highway No. 2, as it is now laid out and maintained; thence in a Northwesterly direction on the said Southern boundary line of said highway to a point where said line intersects with the Western line of the above-described forty; thence south on said line to the point of beginning.
