Clearwater County is pleased to offer you a new service:
The Direct Payment Plan for Real Estate Taxes

With this new program, you can have your property tax payment made automatically from your checking or savings account. You won't have to change your present banking relationship to take advantage of this service.

The Direct Payment plan will help you in several ways:

- Saves time – No checks to write
- Helps meet your commitment in a convenient and timely manner – even if you're out of town or on vacation
- No lost or misplaced statements, your payment is always on time
- Easy to sign up for, easy to cancel
- No Late charges
- *This agreement will be voided if your account has non-sufficient funds on the installment date and you will be charged a \$25.00 handling fee.*

You authorize payments to be made from your checking or savings according to the following schedule:

January 15th Estimated 1st half installment
February 15th Estimated 1st half installment
March 15th Estimated 1st half installment
April 15th * Adjusted Installment for 1st half
May 15th Last Installment for 1st half
June 15th 1st Installment for 2nd half tax
July 15th 2nd Installment for 2nd half tax
August 15th 3rd Installment for 2nd half tax
Sept 15th 4th Installment for 2nd half tax
October 15th Final payment for current yr .tax

Then just sit back and relax. Your payments will be made automatically. Proof of payment will appear with your bank statement. A schedule will be mailed to you in March. **Please notify The County Auditor/Treasurer's Office when you change banks or account number to continue this plan.**
