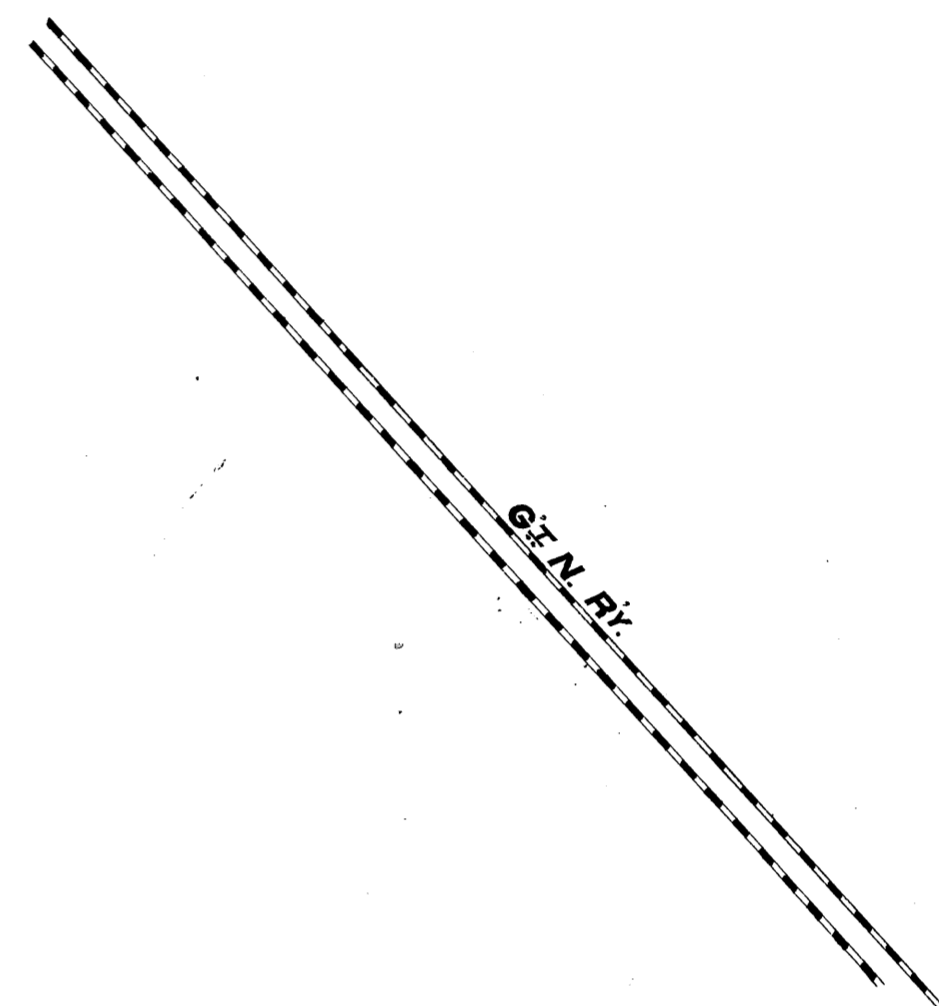
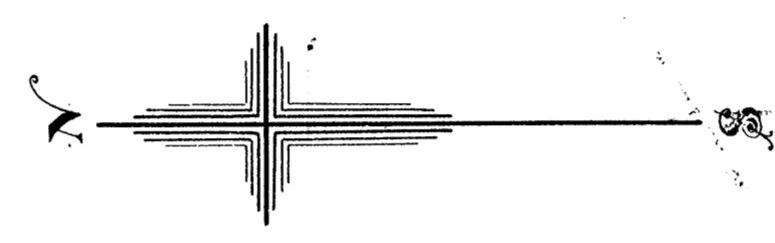
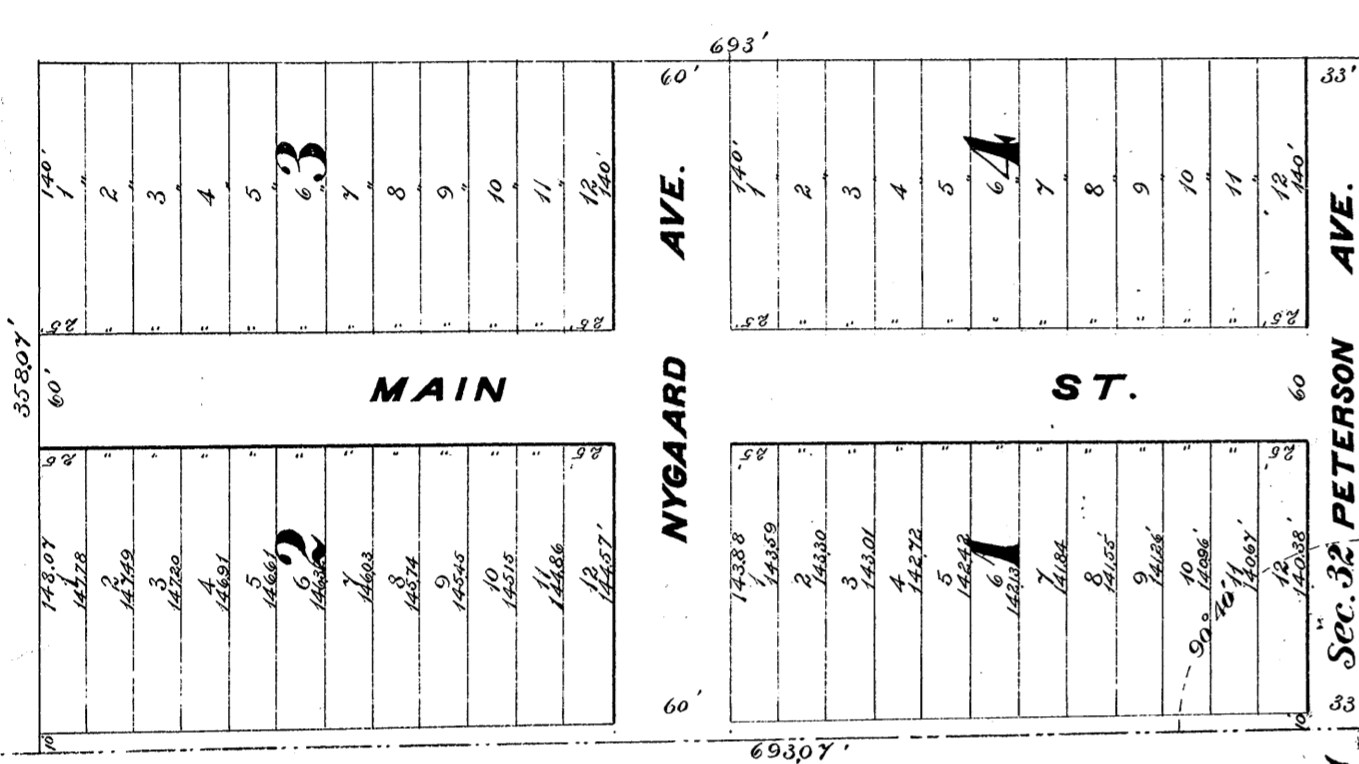


Blocks 2, 3 & 4 of Ebro created by court order dated Feb. 14th 1908 - Recorded in Book 2 of Misc. page 627

Description The tract of land designated by the plat contained on this page and to be known as Ebro is situate in the South West 1/4 of the South West 1/4 of sec. 32 T. 147 North of Range 38 West of 5th Prin. Mer. and more fully described as follows to-wit: Beginning at the corner between 31st and 32nd on the down line, said down line running North along the sec. line between said secs. a distance of 693.07 ft. thence easterly making a deflection angle of 90° 40' a distance of 35807 ft. thence southerly making a deflection angle of 90° a distance of 693 ft. to the intersection with the down line between townships 146 & 147, thence westerly along said down line 447 ft. to the place of beginning, containing 5 2/100 Acres which are subdivided into blocks, lots, streets and alleys. The blocks are numbered in large black figures, the lots in small black figures and the dimension of all lots, streets and alleys are as shown on plat. An iron monument was placed at the S.W. corner of the town site for the guidance of future surveys.
