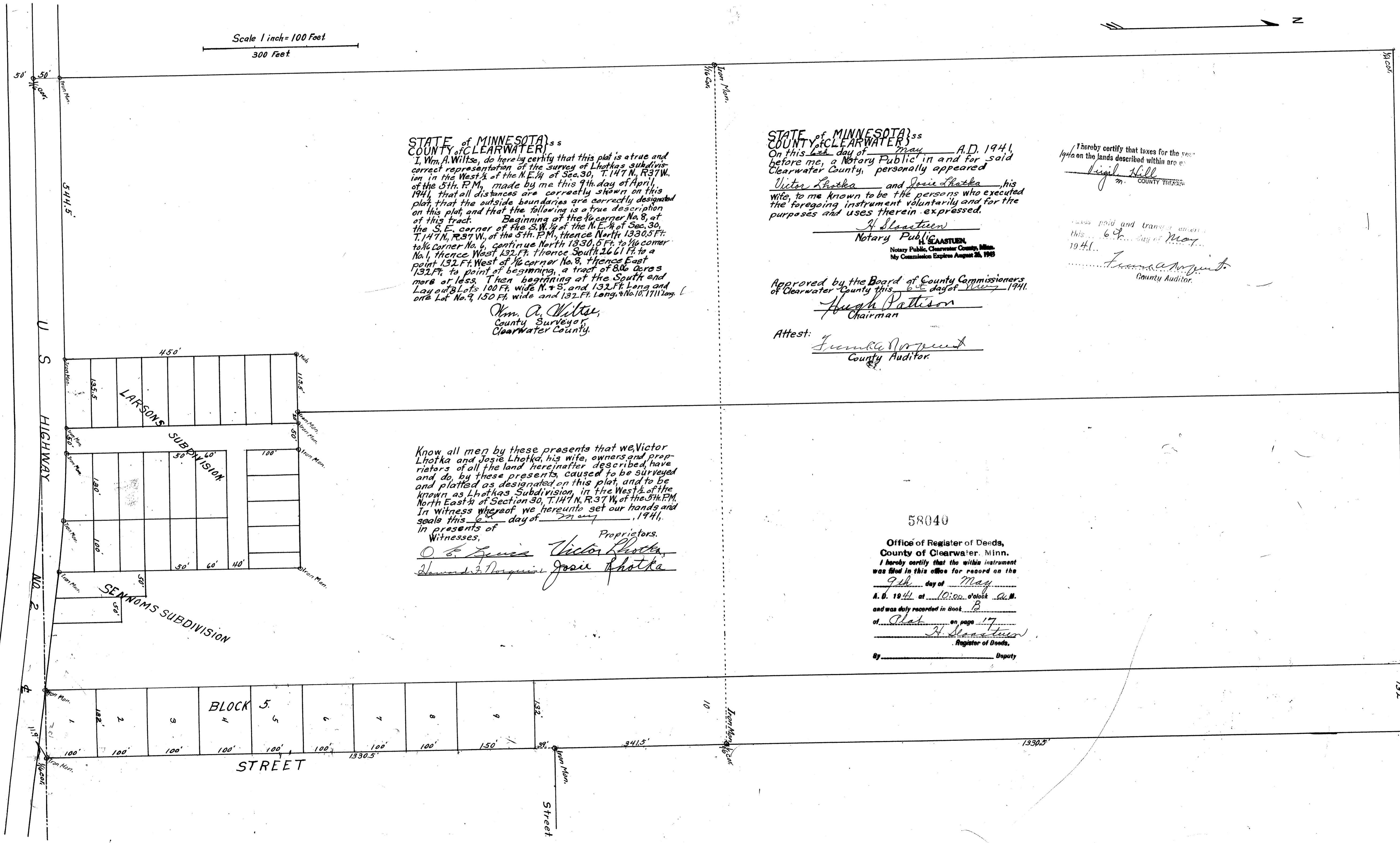
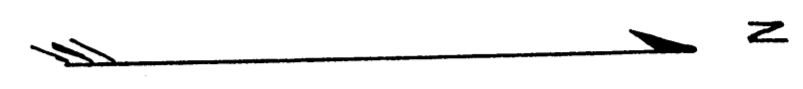


LHOTKAS SUBDIVISION

Wittse, do hereby certify that this plat is a true and correct representation of the survey of Lhotkas subdivision in the West 1/2 of the N.E. 1/4 of Sec. 30, T. 147 N., R. 37 W., of the 5th P.M., made by me this 9th day of April, 1941, that all distances are correctly shown on this plat, that the outside boundaries are correctly designated on this plat, and that the following is a true description of this tract: Beginning of the 1/4 corner No. 8, at the S. E. corner of the S.W. 1/4 of the N.E. 1/4 of Sec. 30, T. 147 N., R. 37 W., of the 5th P.M., thence North 1330.5 Ft. to 1/4 corner No. 6, continue North 1330.5 Ft. to 1/4 corner No. 1, thence West of 1/4 corner No. 8, thence East 132 Ft. to point of beginning, a tract of 8.06 acres more or less. Then beginning at the South end Lay out 3 Lots, 100 Ft. wide N + S, and 132 Ft. Long and one Lot No. 3, 150 Ft. wide and 132 Ft. Long, No. 10, 1711 Long.
