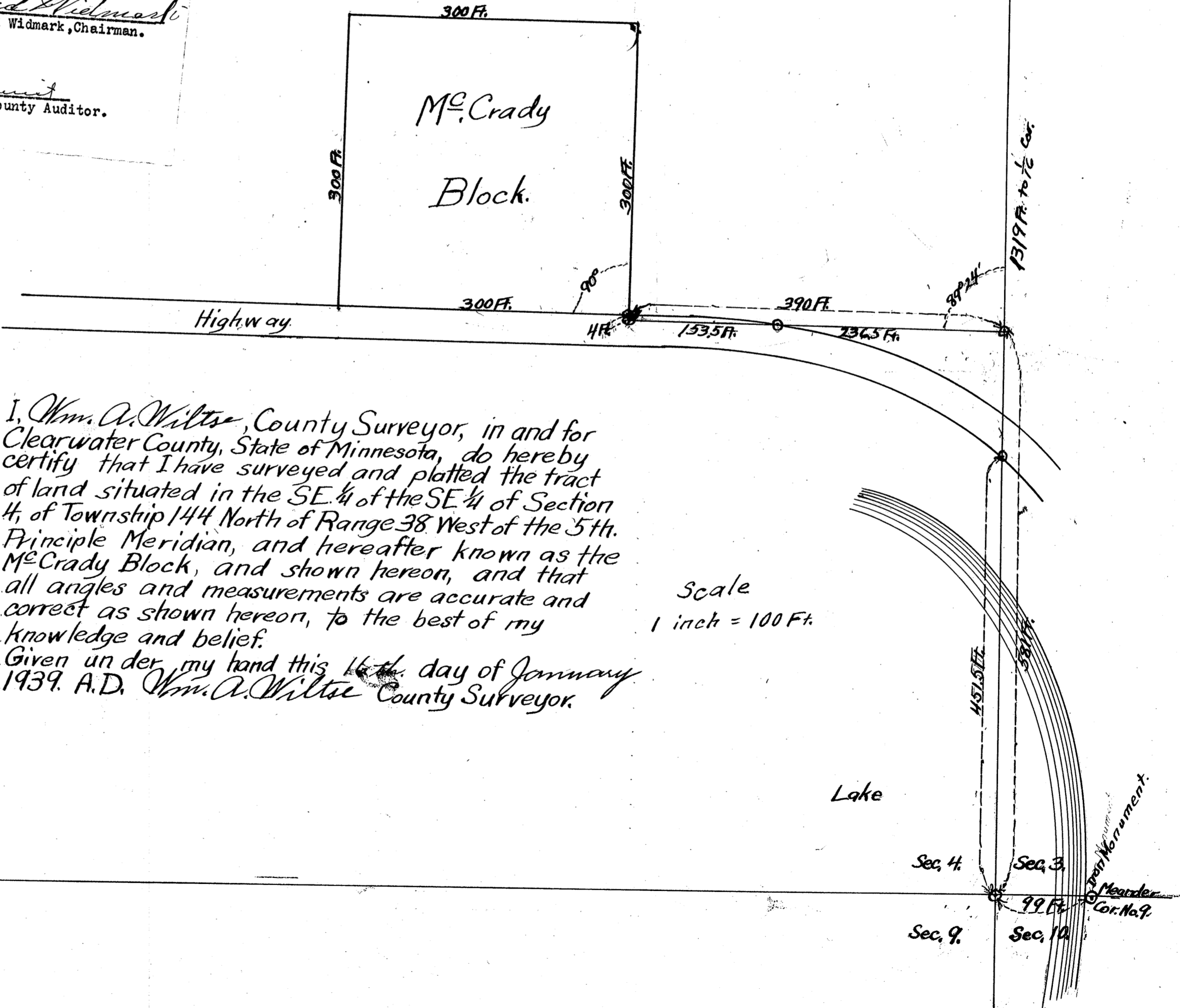


# PLAT OF THE M<sup>C</sup>CRADY BLOCK

Commencing at a point 4 Ft. North and 390 Ft. West from a point on the East line of lot 5 - Sec. 4 in T<sup>ownship</sup> 144 N. Range 38 W. of the 5th Principal Meridian, a distance of 581 Ft. North of the South East corner of said Sec. 4, as a point of beginning; thence North on a line parallel to the East line of said lot 5, 300 Ft. thence West 300 Ft., thence South 300 Ft. thence East along R.O.W. line of Highway to point of beginning, 300 Ft. thereby laying out a block of land 300 Ft. square, and to be known hereafter as the M<sup>C</sup>Crady Block.
