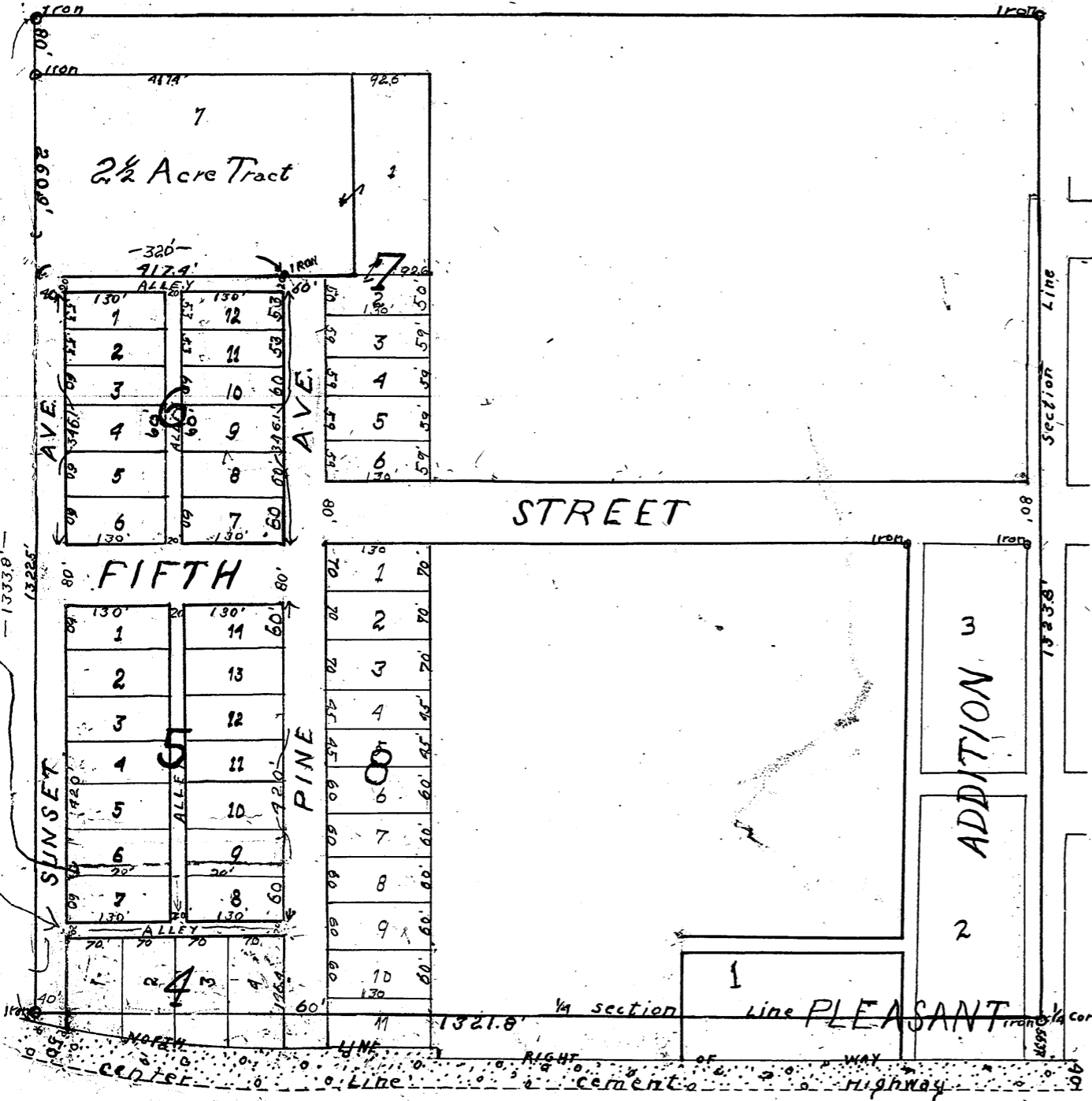


PLEASANT ADDITION TO BAGLEY BLOCKS 4-5-6-7 and 8
